Discussion took place regarding the purchase of property.

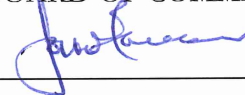
Motion by Commissioner Greg Krueger, seconded by Commissioner James Brady to exit Closed Session at 5:28 p.m.
